### **Crypto industry cheers ‘historic move’ as Ethereum ETFs get the greenlight**

In a historic move, the SEC approved pivotal 19b-4 filings for the spot Ethereum ETF applicants, putting the products squarely on the road to launch. While the SEC must still approve S-1 registration statements in order for the products to go live, some analysts believe this could occur in two weeks, though others suggest it will more likely take a few months. Nevertheless, the approval marks a stunning turn of events for something that was considered a long shot just a week ago. Most importantly, the spot Ethereum ETFs will ease access to ETH, continue to legitimize crypto as an asset class, and is due to and accompanied by a changing stance towards crypto by the US.

### **Spot Ether ETF Approval Proves ETH is Not a Security, Experts Say**

There has been much uncertainty over the years as to whether ETH is a commodity or security, with even the SEC itself launching an official investigation into the matter. The approval of the spot Ethereum ETF 19b-4 filings by the SEC as commodity-based trust shares, however, implies that the SEC explicitly recognizes that ETH is not a security, according to legal experts.

### **House of Representatives pass clarity-seeking FIT21 bill with bipartisan support**

FIT21, which seeks to establish a comprehensive regulatory framework for digital assets in the US, passed in the House with flying colors this week. While odds of Senate passage are less clear (the bill was said to face an uphill battle as of last week), passage in the House is particularly notable given the level of bipartisan support, the amount of progress made (this is the furthest such a comprehensive US crypto bill has made it), and as it demonstrates some loosening of the US's view towards crypto.

## **Biden may rethink SAB 121 vote veto due to political support for crypto**

The Senate passed a measure to overturn SAB 121, the SEC's controversial crypto custody bill, last week. While President Biden had pledged to veto the bill, the political landscape has quickly changed, and observers will closely watch whether Biden follows through on his promise. Media reports now suggest that Congress did not send the measure to the White House until Wednesday, pushing back the 10 day window for Biden's promised veto to June 3.

## **Gemini to return 97% of frozen assets in-kind to Earn users by month's end**
