SEC And Gary Gensler Believed Ether Was A Security For At Least A Year, New Court Docs Reveal

The United States SEC and its Chair Gary Gensler appear to have believed Ether (ETH) was a security for at least a year-long period, according to recent court filings. According to a complaint made by Ethereum development firm ConsenSys, the SEC Director of Enforcement Gurbir Grewal launched an investigation into "Ethereum 2.0" on March 28, 2023, over "possible offers and sales, since at least 2018, of certain securities, including, but not limited to ETH, as to which no registration statement was or is in effect ... and for which no exemption was or is available." ConsenSys formally filed litigation against the SEC last week for its attempt to regulate ETH as a security, while ConsenSys received a Wells notice from the SEC on April 10 warning the company of a potential impending action.

Breaking: EigenLayer Floats EIGEN Token Whitepaper On GitHub

EigenLayer, an Ethereum-based security-as-a-service protocol, released the whitepaper for its EIGEN token on GitHub. The token looks to extend EigenLayer security by using EIGEN staking and a new token forking mechanism to mediate debates that are more subjective in nature and unable to be done onchain (EigenLayer is calling these "intersubjective faults"). Aside from the novel token use case, EigenLayer's token release plans caused controversy as airdropped tokens will be non-transferable and are not claimable by residents from 30 countries.

Spot bitcoin ETFs record largest daily net outflows ever

The US spot Bitcoin ETFs saw over \$525m of outflows on Wednesday, May 1, which included BlackRock's first ever daily outflow of \$37m from IBIT. The spot Bitcoin ETFs have now experienced net outflows seven trading days in a row, losing \$1.2b over this time.

Hong Kong Bitcoin and Ether ETFs have tough debut on first-day trading

The launch of Bitcoin and Ethereum ETFs in Hong Kong saw a disappointing first day trading volume of \$12m, significantly lower than the \$4.6b trading volume of the US Bitcoin ETFs. Despite this, the China AMC Bitcoin ETF took in \$123m on its first day, which ranks sixth of the 82 ETFs launched in the past three years in Hong Kong.

Binance Founder Changpeng Zhao Gets 4-Month Prison Sentence

Binance founder Changpeng Zhao (CZ) was sentenced to four months in jail and fined \$50m for violating the Bank Secrecy Act by a Seattle court. The four-month sentence is well below the 36 months requested by the Department of Justice and the 18 months laid out in Zhao's previous plea agreement.
