Crypto Black Monday: Global Stock Market Plummets, Bitcoin Price Falls Below \$50,000

Crypto prices cratered on Monday as panic ensued, with Bitcoin and Ethereum down more than 30% from just a week prior at one point. Crypto was impacted by turmoil in the traditional markets due to the unwind of the Yen carry trade, increased worries around US economic growth, and rising tensions in the Middle East. In addition, crypto was also impacted by impending Mt Gox distributions, mixed spot digital asset ETF flows, a rising appreciation that Trump may not win the Presidency, and reports of a large market maker dumping hundreds of millions of dollars of crypto.

A New York judge ordered Ripple to pay a \$125m penalty in its long-standing lawsuit with the SEC, down substantially from the \$2b the SEC requested. Many view it as a win for crypto, and all eyes now turn to whether or not the SEC appeals the ruling.

Judge approves \$12.7 billion settlement between FTX and CFTC, bringing 20-month-long lawsuit to an end

A US judge approved a \$12.7b settlement between FTX, Alameda Research and the CFTC, with FTX and Alameda required to pay \$8.7b in restitution to those

who suffered losses and an additional \$4b in disgorgement. Importantly, the CFTC agreed it would receive nothing as long as FTX complies with its reorganization plan, so the full \$12.7b will go to creditors, subject to available funds. The settlement brings the 20-month-long lawsuit to an end following one of the biggest financial frauds in US history.
