Bitcoin falls alongside stocks following Bank of Japan rate hike comments

Macroeconomic fears dragged on global equity markets this week, with the S&P 500 down 4% and Japan's Nikkei 225 Index down 7%. At issue are signs of slowing US growth, spurred by a poor manufacturing gauge at the beginning of the week and bookended with a slightly worse-than-expected employment report today. Further, the Bank of Japan reiterated that it will continue to raise interest rates should its outlook be realized, stoking fears of further yen carry trade unwind. The macroeconomic worries weighed on crypto markets, with Bitcoin and Ethereum down 9% and 11% over the last seven days, respectively.

Brazil's Top Court Suspends Elon Musk's X Nationwide

Brazil's Supreme Court suspended X (formerly Twitter) after Elon Musk failed to appoint a legal representative in the country, and stated the suspension will last until X complies with all court orders and pays existing fines. Issues began in April, with Judge Moraes ordering the suspension of dozens of X accounts for allegedly spreading disinformation. X responded by saying it will not comply with Brazil's demands and believes the judge's orders are to censor political opponents.

Arbitrum Ships Stylus Upgrade

Ethereum L2 Arbitrum launched its long-awaited Stylus upgrade to enable developers to write smart contracts in Rust, C, and C++. The upgrade should vastly expand the potential developer pool, as there are an estimated 20,000

solidity developers versus 2.5m Rust devs and 10m C++ devs.

Polygon to Start Much-Awaited Swap of POL Token for Longstanding MATIC

Polygon developers have migrated the MATIC token to POL after a year of extensive community-led discussions. This change introduces POL as the new ticker symbol for the native gas and staking token on the Polygon PoS chain, while the future will see the upgraded POL token have expanded functionalities including roles in block production, zero-knowledge proof generation, and participation in Data Availability Committees.

Cardano shifts to decentralized governance as Chang hard fork goes live

Following years of effort, the first stage of Cardano's Chang upgrade has gone live, transitioning ownership of the blockchain to holders of its native ADA token. Over the next 90 days, Cardano will undergo a full transformation to a community-led governance model overseen by an interim committee. At the end of the 90 days, the second stage of the Chang hard fork will activate, fully turning power over to its new governance bodies, which include a constitutional committee, delegate representatives, and staking pool operators. The upgrade marks a significant step to decentralized governance for the network.
