### Crypto markets reel as Middle East conflict sparks global uncertainty

Crypto Briefing

Rising tensions in the Middle East weighed on risk appetite and crypto prices last week. Specifically, Iran launched a missile attack on Israeli security and military targets in response to the killing of a Hezbollah political leader. The fighting later intensified in Lebanon, causing fears of an all-out war between Israel and Iran. The uncertainty and falling prices caused over \$500m of 24h liquidations at one point earlier in the week, and the Crypto Fear & Greed Index currently sits at Fear compared to Greed a week ago.

### Japan's Next Prime Minister Announces Pro-Blockchain and NFT Policy Plans

Markets were spooked early in the week after Japan's ruling Liberal Democrats party chose Shigeru Ishiba as the next prime minister, as some believe Ishiba is more likely to increase interest rates than the other candidates. Still, the yen soon weakened against the US dollar, challenging this oft-reported notion. Moreover, Ishiba revealed a desire to foster blockchain technology and NFTs in an official policy document, and Japan's new Digital Transformation Minister hinted that he will push for crypto tax reform.

### Tokenized funds get preliminary approval to be used as collateral in the US

A CFTC subcommittee approved guidelines for using tokenized money market fund shares as collateral in financial transactions. While a full vote is still needed to enact the measure, such a move could spark the adoption of tokenized collateral in traditional markets.

### SEC's enforcement director announces departure

Gurbir Grewal, SEC's enforcement director since July 2021, will leave the agency this

month, with Sanjay Wadhwa stepping in as acting director. Under Grewal, the SEC took 35 crypto enforcement actions in 2022 and 40 in 2023, and expanded its crypto unit to 50.
