## Top Stories of The Week

### **How Incompetence and Greed Led Argentina's Javier Milei to Become the Face of the \$4.5B LIBRA Scam**

The Defiant

On Friday, Argentine President Milei promoted the LIBRA memecoin, which shot up to a \$4b market cap before quickly crashing. Some claimed it to be an organized operation with an intricate network of memecoin power brokers, influencers, and protocols working to impact the price and dump on retail. Milei retracted his endorsement, and there is now significant fallout, both in Argentina and with many questioning the future of memecoins.

### **FTX creditors begin receiving \$1.2 billion in payouts with interest on Kraken**

FTX creditors are receiving initial payouts of \$1.2b via Kraken, with those under \$50,000 getting full reimbursements plus 9% interest. Larger claims will be paid in Q2 2025. The bankruptcy process has recovered more assets than expected, allowing for significant returns.

### **SEC Backs Off Crypto Dealer Fight, Continues Resetting Industry Approach**

The SEC has dropped its appeal against a ruling that deemed its expanded definition of securities dealers for digital assets as exceeding statutory authority. This shift, under new leadership, signals a move towards more collaborative regulation of crypto, aiming to stabilize markets and reduce litigation risks.

## Coinbase Expands US Crypto Futures Market with CFTC-Regulated Solana Contracts

Coinbase is launching CFTC-regulated Solana and Hedera futures contracts, expanding its offerings to 19 futures. This move aims to integrate crypto with traditional finance.

## Hyperliquid Launches HyperEVM to Enable General-Purpose Programmability

Hyperliquid launched HyperEVM, an Ethereum-compatible execution environment on its Layer 1 blockchain, enhancing smart contract functionality. The platform achieved \$15b daily trading volume and \$2.1b total value locked in 2024, with a user base growing to 300,000.
