Crypto Market Cap Tumbles 6% as Trump's Policies Stoke Fears of Economic Fallout

News

The crypto market fell 6% amid investor uncertainty over Trump's trade policies targeting major U.S. trading partners like Canada, Mexico, and China. Liquidations exceeded \$939M, affecting over 300K traders. The Strategic Bitcoin Reserve announcement failed to stabilize markets, reflecting broader economic pessimism.

Binance Gets \$2B Investment From Abu Dhabi's MGX

Abu Dhabi-based investment firm MGX has invested \$2 billion in Binance, marking the crypto exchange's first institutional placement and MGX's initial foray into digital assets. The investment was made in stablecoins, though the specific currency was not disclosed. Binance, the world's largest crypto exchange by trading volume, has a significant presence in Abu Dhabi with around 1,000 employees, and its CEO, Richard Teng, previously served as the head of the Abu Dhabi Financial Services Regulatory Authority.

Senate Banking Committee votes to advance stablecoin bill, collecting support from both Democrats and Republicans

The Senate Banking Committee has advanced the GENIUS Act, a significant stablecoin bill, to the full Senate for debate. The bill passed with an 18-6 vote, including support from several Democrats. Congressional analysts believe the bill has a clear path to approval in the Senate.

Trump's Crypto Summit Sets Agenda for U.S. Pivot

President Trump held a historic White House summit with crypto leaders, pledging to end regulatory hostility and support stablecoin legislation. He announced a new Bitcoin reserve, leveraging the U.S. government's 200,000 Bitcoin holdings. The administration aims to foster innovation and economic growth in the crypto sector.

Spain's Second-Largest Bank BBVA To Offer Customers Bitcoin, Ethereum Trading
