Crypto markets fall after Trump lays out sweeping reciprocal tariffs; Ethereum, Solana drop 6%

The Block

President Donald Trump's announcement of sweeping reciprocal tariffs led to a significant downturn in the cryptocurrency market, with Ethereum and Solana each dropping 6%. The newly announced tariffs include a baseline 10% duty on all imports, with higher rates for specific countries. This policy shift has intensified fears of a global trade war, resulting in substantial losses across financial markets.

Stablecoin issuer Circle takes another stab at a public listing

Circle has filed for an initial public offering (IPO) after a previous attempt via a SPAC merger in 2022 was unsuccessful. In 2024, the company reported revenue and reserve income of \$1.68 billion and a net income of \$156 million. The IPO filing comes amid the Trump administration's supportive stance on crypto assets.

FDUSD stablecoin depegs 9% after Justin Sun raises concerns over First Digital's solvency

The Block

Justin Sun warned users to withdraw funds from First Digital Trust (FDT), alleging insolvency after FDT reportedly redirected nearly \$500 million of TUSD reserves into illiquid investments. Sun's comments triggered a 9% drop in FDT's stablecoin FDUSD, erasing \$130 million from its market cap, though FDT denied the claims, asserting FDUSD reserves remain fully secure.

House Financial Services Committee votes to advance bill to regulate stablecoins

The House Financial Services Committee advanced the STABLE Act, a bill to regulate stablecoins, with a 32-17 vote, setting reserve and capital standards such as one-to-one backing and anti-money laundering measures. The bill faces challenges, including scrutiny over President Trump's family involvement in crypto ventures, which some lawmakers claim presents conflicts of interest. The bill must still align with a differing Senate version, the GENIUS Act, before becoming law.

Bitcoin DeFi protocol Babylon to airdrop 600 million BABY tokens in upcoming token generation event

The Block

The Babylon Foundation announced an upcoming token generation event for its BABY token, allocating 6% of the 10 billion total supply to early supporters, including stakers, NFT holders, and GitHub contributors. BABY tokens will facilitate staking, governance, transaction fees, and security within Babylon's Genesis Chain, its Bitcoin-secured network. Babylon previously raised \$70 million in a round led by Paradigm in May 2024.
